Prior to filing a Petition for a Personal Property Foreclosure you must comply with the procedures listed below;

1. Submit **three (3)** copies the Personal Property Foreclosure Summons by filling out the “Plaintiff and Party to be services” (Defendant) sections.
2. Submit **three (3)** copies of the contract or other agreement, etc. (one (1) copy for the file and two (2) copies attached to the Personal Property Foreclosure Summons).
3. Submit **three (3) copies [ONE with and Original Signature]** of the Affidavit for Foreclosure of Personal Property, by inserting the names and addresses of Plaintiff and Defendant on the designated lines. Also indicate by circling the  the appropriate answers requested in the Affidavit and the Person filing will be sworn in by the Deputy Clerk and sign as “Affiant”.
4. Complete the Plaintiff and Defendant sections on the Application and Writ of Possession and sign as Plaintiff (Agent). Complete the “Marshall’s Greetings” section, by listing the items (INCLUDE ALL **SERIAL #’s AND MODEL #’s** FOR EACH ITEM) being foreclosed upon.
5. Please sign as Plaintiff (Agent) in the “Election of Option”. Be sure to **X** your choice.
6. Complete the Plaintiff and Defendant sections on the “Notice for Hearing” page.
7. The “Order”: Complete Plaintiff & Defendant sections and print (legibly) a detailed list of items (INCLUDE ALL **SERIAL #’s AND MODEL #’s** FOR EACH ITEM) that are being foreclosed upon.
8. Cost: Filing fees are set forth by the Georgia State Legislative body and are subject to change. Current fees can be found by clicking the Filing Fees link located on the Home Page

Your Petition will be returned or dismissed if the above procedures are not followed correctly.
